February 22<sup>nd</sup> was the last day for bills to be introduced in the Legislature. Below is a list of the 160 significant impact/priority one bills that the University is currently tracking;

Requires an institution of higher education, as a condition of its participation in the Cal Grant Program, to implement a financial aid book advance program that would provide a line of credit for the purchase of books and educational materials at bookstores owned by or located on the campus of the institution to each student who is owed a credit balance for certain financial aid awards and who has not opted out of the program.
AB	515	Mathis (R)	02/21/2019 - To ASSEMBLY Committee on HEALTH.	Prohibits the State Department of Health Care Services from assessing or collecting interest on the recovery of an overpayment from a federally qualified health center or a rural health clinic located in a medically underserved area.
AB	521	Berman (D)	02/13/2019 - INTRODUCED.	Legislative intent: Enact legislation to provide physician and surgeons with training regarding firearm safety.
AB	528	Low (D)	02/21/2019 - To ASSEMBLY Committee on BUSINESS AND PROFESSIONS.	Requires a dispensing pharmacy, clinic, or other dispenser to report the information required by the CURES database no more than one working day after a controlled substance is dispensed.
AB	534	Mayes (R)	02/21/2019 - To ASSEMBLY Committees on HUMAN SERVICES and AGRICULTURE.	Requests UC, CSU and CCC to develop systems that allow EBT cards to be used on their respective campuses. (AB 1952 '18)

AB	540	Limon (D)	02/25/2019 - To ASSEMBLY Committee on HIGHER EDUCATION.	Establishes the Cal Grant B Service Incentive Grant Program. Requires a participating student, in order to receive a grant award under the program, to be a recipient of a Cal Grant B award, to be enrolled as a student at UC, CSU, CCC or independent institution of higher education, and to perform at least 100 hours per quarter or 150 hours per semester of community or volunteer service, as provided.

Repeals the limitation on eligibility for Competitive Cal Grant A and B Awards for students who are exempt from paying nonresident tuition. Legislative intent to make all forms of state-based aid in California be made equally available to these students who are exempt from paying nonresident tuition and to all other students who qualify for state-based aid.
AB	543	Smith C (D)	02/25/2019 - To ASSEMBLY Committees on EDUCATION and HIGHER EDUCATION.	Requires each educational institution to create a poster that notifies pupils of the institution's written policy on sexual harassment and to prominently and conspicuously display the poster in specified public and private areas on campus.
AB	565	Maienschein (D)	02/25/2019 - To ASSEMBLY Committee on HEALTH.	Defines "practice setting" under the Steven M. Thompson Physician Corps Loan Repayment Program in the California Physician Corps Program to include a program or facility operated by, or contracted to, a county mental health plan.
AB	577	Eggman (D)	02/25/2019 - To ASSEMBLY Committee on HEALTH.	Extends Medi-Cal postpartum care for up to one year beginning on the last day of the pregnancy for an eligible individual diagnosed with a maternal mental health condition.
AB	603	Melendez (R)	02/28/2019 - To ASSEMBLY Committee on PUBLIC SAFETY.	Amends the Safety For All Act of 2016 by redefining honorably retired to include a member of the University of California Police Department who has qualified for and accepted Duty Disability Income or an equivalent status pursuant to the University of California Retirement Plan.

Requires public school, including a charter school, or a private school that serve grades 7 to 12 and postsecondary educational institutions, if they issue pupil or student identification cards, to have printed on the back of those identification cards the telephone numbers for the National Sexual Assault Hotline, the National Domestic Violence Hotline, and a sexual or reproductive health hotline.

Amends the Clinical Social Worker Practice Act to remove the exemption for graduate students and social work interns working in a recognized training program from the provisions otherwise pertaining to clinical social workers.
AB	678	Flora (R)	02/28/2019 - To ASSEMBLY Committee on HEALTH.	Provides that the exclusion of podiatric services is effective only through 12/31/2019 and restores podiatric services as a covered benefit of the Medi-Cal program as of 1/1/2020.

Requires the Department of Health Care Services to disregard specified assets and resources in determining the Medi-Cal eligibility for an applicant or beneficiary whose eligibility is not determined using modified adjusted gross income (MAGI), subject to federal approval and federal financial participation.

Exempts from disclosure in the California Public Records Act, the personal telephone numbers of public postsecondary educational institution faculty members and records relating to the physical location of faculty members, including calendars, appointment logs, and home addresses.

Makes provisions to offer a patient a prescription for the complete or partial reversal of opioid depression applicable only to a patient receiving a prescription for an opioid or benzodiazepine medication and makes the provisions specific to opioid-induced respiratory depression, opioid overdoes, opioid use disorder, and opioid overdose prevention.

Requires, upon receipt of federal approval, all countable income over 100% of the federal poverty level, up to 138% of the federal poverty level, to be disregarded, after taking all other disregards, deductions, and exclusions into account for those persons eligible under Medi-Cal program for aged and disabled persons.

Requires a contract issued, amended, or renewed on or after 1/1/20, between a health care service plan and a healthcare provider for the provision of healthcare services to an enrollee or subscriber, or a contract issued, amended, or renewed on or after 1/1/20, between a health insurer and a healthcare provider for an alternative rate of payment to specify that the health care service plan or health insurer reimburse a healthcare provider for the diagnosis, consultation, or treatment of an enrollee, subscriber, insured, or policyholder delivered through telehealth services on the same basis and to the same extent that the health care service plan or health insurer is responsible for reimbursement for the same service through in-person diagnosis, consultation, or treatment.

Requires the Superintendent of Public Instruction to approve a nationally recognized high school assessment that a local educational agency, may, at its own discretion, administer, if the alternative assessment is approved by the local educational agency's governing board or body in a public meeting, commencing with the 2021-22 school year, and each school year thereafter, in lieu of the consortium summative assessment in English language arts and mathematics for grade 11. (AB 1951 '18)
AB	774	Reyes (D)	02/28/2019 - To ASSEMBLY Committee on HEALTH.	Amends existing law which requires hospitals to file an Emergency Care Data Record for each patient encounter in a hospital emergency department with the Office of Statewide Health Planning and Development to include the time of registration and, as applicable, the date and time of admission, transfer, and discharge, as well as the location of the discharge and transfer.
AB	806	Bloom (D)	03/04/2019 - To ASSEMBLY Committee on HIGHER EDUCATION.	Requires CSU and CCC and requests UC to add former homeless youth to the students to be granted, or requested to be granted, priority enrollment.
AB	809	Santiago (D)	03/04/2019 - To ASSEMBLY Committee on HIGHER EDUCATION.	Requires public postsecondary institutions to post on each institution's internet website, and to provide to an expectant parent through on-campus health clinics, notification of protections under Title IX for pregnant students and parenting students.
AB	829	Bloom (D)	03/04/2019 - To ASSEMBLY Committee on HIGHER EDUCATION.	Authorizes CSU to establish Occupational Therapy Doctorate degree programs to focus on preparing occupational therapists to provide health care services.
