Budget Update

The Governor's May Revise proposal was unveiled on May 11th and during most of the remainder of the month the Assembly and Senate Budget Sub Committees worked on the proposal approving some of it and making modifications, additions and subtractions elsewhere. The below chart summarizes the latest actions on the state budget as it pertains to the University of California.

The Conference Committee has already met and will continue to meet over the next couple weeks to resolve differences between the two houses as shown above. Once items are resolved the budget will be taken up by the legislature and then sent to the Governor for final approval. The legislature has until June 15th to approve the budget.

Actions on UC Tracked Bills

The last week in May was reserved for floor session only. Below is a list of bills the University is tracking that made it out of their respective houses;

AB 2220 (Bonta) passed off of the Assembly Floor. The bill would require UC and CSU campuses that provide athletic scholarships for student athletes to comply with the College Student Athlete Bill of Rights, and extends scholarships to injured student athletes for an additional year beyond the 5-year limit. The University has an Oppose position on the bill.

AB 2361 (Weber) passed off of the Assembly Floor. The bill would request UC to record and report to the Legislature, through a publicly accessible UC Website information regarding service work performed by a contractor pursuant to an outsource contract. The University has an Oppose position on the bill.

AB 2470 (Grayson) passed off of the Assembly Floor. The bill would establish the Invasive Species Council of California. The University's position on the bill is pending.

AB 2477 (Rubio) passed off of the Assembly Floor. The bill would require CCC and CSU and requests UC to designate a Dream Resource Liaison on each of their respective campuses. The University has a Support position on the bill.

AB 2747 (Holden) passed off of the Assembly Floor. The bill would authorize institutions of higher education to establish a degree completion fund under the Student Athlete Bill of Rights, and to prepare notices containing pertinent data regarding student athletes rights, and procedures for filing complaints. The University's position on the bill is pending.

AB 2771 (Eggman) passed off of the Assembly Floor. The bill would enact the Higher Education Facilities Bond Act of 2018 to authorize the issuance of \$7B in state GO bonds for the construction, reconstruction, and remodeling of facilities at UC, UC Hastings, and CSU. The University's position on the bill is pending.

AB 2785 (Rubio) passed off of the Assembly Floor. The bill would require CCC, CSU and UC to provide reasonable accommodations to a lactating student on their respective campuses. The University's position on the bill is pending.

AB 2798 (Maienschein) passed off of the Assembly Floor. The bill would prescribe timelines for the approval of a written application submitted by a general acute care hospital to modify, add, or expand a service or program. The University's position on the bill is pending.

AB 2989 (Flora) passed off of the Assembly Floor. The bill would authorize transit development boards and public agencies, including UC and CSU, to adopt ordinances, rules, and regulations for the use of standup electric scooters. The University's position on the bill is pending.

AB 3153 (Levine) passed off of the Assembly Floor. The bill would extend Cal Grants to summer session. The University has a Support position on the bill.

SB 967 (Berryhill) passed off of the Senate Floor. The bill would prohibit CSU and CCC, and UC only if it acts by resolution, from charging mandatory system wide tuition or fees to current or former foster

youth, who meet certain requirements, for a total of the equivalent of attendance in a 4-year undergraduate program. The University's position on the bill is pending.

SB 1186 (Hill) passed off of the Senate Floor. The bill would require law enforcement to submit a proposed Surveillance Use Policy to its governing body and to cease using surveillance technology within 30 days if the plan is not adopted. The University has an Amend position on the bill.

SB 1300 (Jackson) passed off of the Senate Floor. The bill would require employers to provide employees 2 hours of sexual harassment and bystander intervention training and information on how to report harassment and make a complaint. The University's position on the bill is pending.
